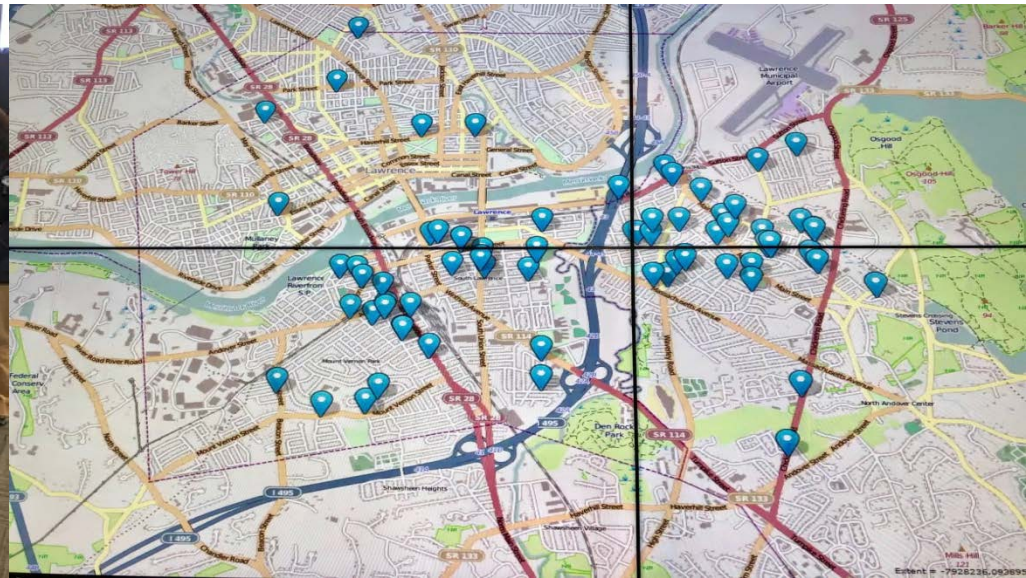

Strengthen and enhance the readiness of the public health system to save lives during emergencies that **exceed the day-to-day capacity and capability** of the public health systems.

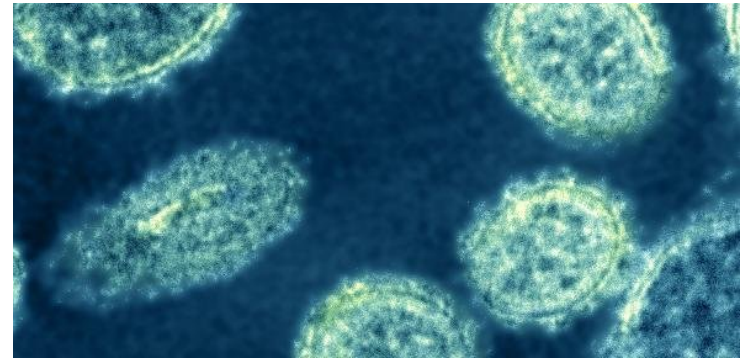

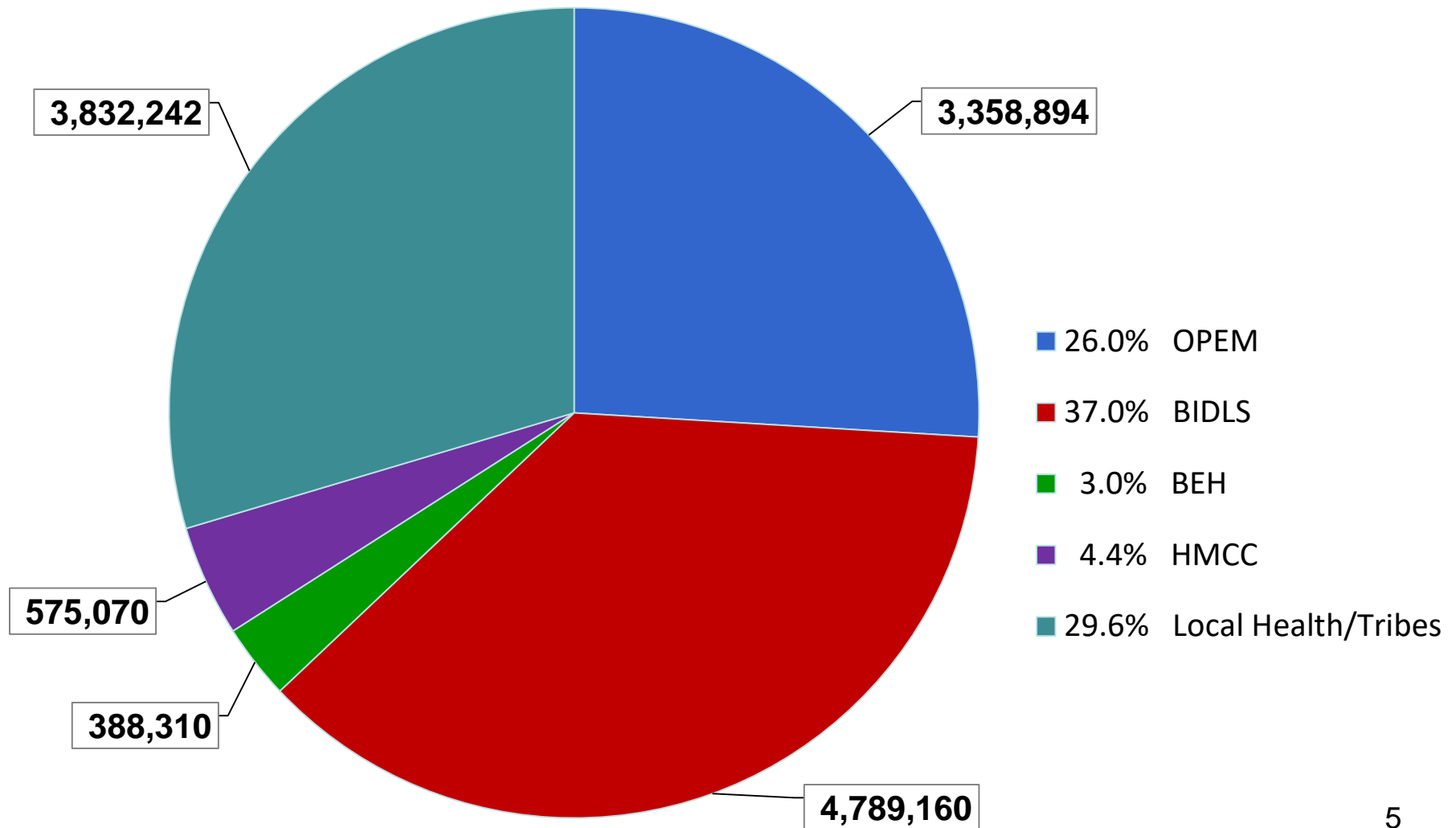

- Base + Population
  - \$3,831 per municipality
  - Percent of the population within each coalition as compared to the population of Massachusetts

# Meningitis Outbreak on University Campus in Massachusetts

- November 2017, three UMass students were diagnosed with Meningitis B
- EDS plans activated and MRC nurses administered 6,900 vaccines
- Following the successful vaccination campaign, no further meningitis cases were found on campus.
